WESTERN REGIONAL GRADUATE PROGRAM (WRGP)

The Western Regional Graduate Program (WRGP) is an agreement among Western Interstate Commission of Higher Education (WICHE) 16 members, through which participating Western public universities allow WICHE-region students to attend select out-of-state graduate certificate, master's, and doctoral programs – and pay up to 150 percent of resident tuition. At Nevada State University, the WGRP rate is the same as in-state resident tuition.

The following WICHE-region states and territories participate in the WRGP program along with Nevada:

• Commonwealth of Northern Marianas Islands and Guam

Applicants must have maintained a legal bona fide resident status in a WICHE-region state for at least 12 months
