

## WESTERN REGIONAL GRADUATE PROGRAM (WRGP)

The Western Regional Graduate Program (WRGP) is an agreement among Western Interstate Commission of Higher Education (WICHE) members, through which participating Western public universities allow WICHE-region students to attend select out-of-state graduate certificate, master’s, and doctoral programs – and pay up to 150 percent of resident tuition.

**The following WICHE-region states and territories participate in the WRGP program along with Nevada:**

- Alaska • Arizona • California • Colorado • Hawai’i • Idaho • Montana • New Mexico
  - North Dakota • Oregon • South Dakota • Utah • Washington • Wyoming
  - Commonwealth of Northern Marianas Islands • Guam • American Samoa
- Freely Associated States: Please refer to NSHE Residency Form*

- **Only NEWLY admitted students** who are accepted in a WRGP-eligible program may apply.
- The WRGP application process must be completed before the student is in attendance at Nevada State.
- Applicants must have maintained a legal bona fide resident status in a WICHE-region state for at least 12 months prior to the first day of the term of attendance.
- The applicant must also be a U.S. citizen or resident alien.
- Continued eligibility for WRGP status is dependent upon “good standing” based on program requirements.

- Driver's license or state identification card
- Vehicle registration
- Voter registration card
- Federal/state income tax return
- Proof of employment (W2s, pay statements)
- Lease or rent receipts
- Utility statements
- Owner-occupied home mortgage documentation/property taxes statement
